

NJ 4-H Senior Rifle Postal Match **Entries Due: November 6, 2010**



Purpose

The purpose of this postal match is to offer all eligible 4-H members an opportunity to compete in a state wide postal match competition. This competition is one of the three components offered by the New Jersey 4-H Shooting Sports Advisory Council for qualifying as a State Team Member for Air Rifle.

Eligibility

All 4-H members who are in good standing and are age 14 by January 1, 2011 are eligible to compete.

Firing Dates

Will be set up by the 4-H Club in which participants are a member of.

Entry Closing Date

All entries **must be received** by Wednesday November 3, 2010. Mail entries to: Barbara Cruz, 48 Rieder Road, Spotswood, NJ 08884. No late entries will be accepted. Entries will be reviewed by the New Jersey State 4-H Shooting Sports Advisory Council Judging Committee.

Rules

Equipment

All rifles accepted at National Level competition may be used. These include: *Daisy Avanti 753, 853, 887, 888, Daisy XSV 40 and Air Arms T-200 that has a non-adjustable cheek-plate and butt-plate.*

Targets

Each participant will receive two targets for the standing position. Only one shot is fired on each record bull. No photocopied targets will be accepted. Official target stickers have been placed on each target per child. Targets without stickers will not be scored. Unlimited sighting shots may be made. If a target is not handed in the score will be a 0.

Scoring

Scoring will be done by the NJ State 4-H Shooting Sports Advisory Council Committee assigned to this event.

Course of Fire/ Target Placement

20 shots at 10 meters – (33 feet)
Placement of the targets is based on measurement from the ground to the center of the target. The Standing position will be used in all shots for the senior division. (20 shots @ 55")

Witness

Shooting will be under the supervision of the 4-H adult leader or 4-H Certified Instructor. The witness will need to sign the enclosed form stating that the 4-H member has met all member in good standing guidelines, and is age eligible. The form must be returned with the targets.

Match Conditions

Eye protection is required.

Notification

Members will be selected for the NJ Team by the NJS4HSSAC Committee. The selection process will be reviewing of the Postal Match Scores as well as the results of the State Qualifying Match. Members of the team will be notified as soon as the selection committee has reviewed both events. Members of the team will be recognized at the State Banquet.
